



The Department of Motor Vehicles is a state agency full of contradictions: originally established for the purpose of abating the public nuisance of speeding drivers, the agency has now imprinted itself upon the cultural imaginary as a public nuisance.

Though it is an arm of the state government fundamentally important to our democracy, by granting identification and voter rights, no agency is more loathed across the population. In spite of helping itself to all the rhetoric of scientific management, boasting a "modern, efficient, cost-effective and convenient service," it remains an infuriatingly ineffective process, requiring long wait times and frustrating paperwork.

Perhaps the reason for our universal outrage with the operations of the agency lies with our expectation: the fact that we arrive at the DMV as consumers rather than as citizens. This expectation is not entirely unjustified; it is inscribed within the history of the agency.

The DMV began as a service rather than as an autonomous space or building type, situated within an existing commercial infrastructure from the very beginning.

In the early 20th century, however, business people were granted agency to handle automobile registration and licensing, augmenting their primary lines of work, which included automobile garage owner, salesman, machinist, glass merchant, dentist, and so forth.

With the postwar economic boom, and the massive state and federal investments in auto-infrastructure, the automobile assumed a 1:1 ratio with the population at large, with driving and the notion of individuality now lastingly joined at the hip.

In a consequential transfer of power, the DMV itself went from being an agency granting driver licenses to an arbiter for the definition of individual identity, thus assuming an essential role in civic life, acting both as the administrative back-of-house and the primary interface between the people and the state.





My thesis rejects the current organization of the DMV experience, which remains largely attached to the mall, situated side by side not with public services but with retail; stores which compete for attention over the agency's drab storefront.

I propose today to look at the ceiling plane as a device for the recuperation of a civic experience from commercial office space and put forward the reflected ceiling plan as a site of invention in redirecting hierarchy, program, and spatial differentiation.







While it may seem mundane and omnipresent, the ceiling is not neutral.

The "false" or "dropped" ceiling was first articulated in the Beaux Arts tradition as a way to mold the interior and elevate new secular civic programs, like the Paris Opera house.

Here, the ceiling was key in creating both a plane of visual projection, as well as defining the collective body that gathered below it.

With the invention of the ceiling as an infinite plane during the modernist era, its surface became separated from its scaffold.

Mies' 1942 perspective for an Opera House, for example, shows a hall of industry in which the modernist blank ceiling plane with its implied limitlessness and independence from wall structure is clearly expressed.


But, even though the ceiling here can be interpreted as structurally superfluous, it still has the potential to function, much like the opera, as a formal shaper of a collective.




As Raymond Hood once said, "the plan is of primary importance because on the floor are performed all the activities of the human occupants," - implying the plan is the primary instrument of getting things done efficiently.

But at the DMV, people spend most of their time waiting, that is, not doing anything.

Thus I would like to propose that here, more than the plan, it is the ceiling, with its atmospheric and immersive attributes, that can operate as a tool for activating and reclaiming this idleness as the instigator for the creation of a collective.

This retrofit takes place in the General Motors Headquarters in Detroit, a tall office building designed by Albert Kahn in 1919.

This iconic building straddled the threshold between the waning Beaux-Arts approach and American industrial modernism, while it also became a catalyst for urban change in Detroit, the Motor City.

In fact, its construction led to the creation of the so-called 'New Center' of the city, three miles north of downtown as a corporate- administrative hub that rebranded itself as the "actual center" of Detroit.

Following its purchase by the State of Michigan in 2011, the GM building houses today a long list of government offices, reaffirming its status as the "actual" administrative center of the city.

Last but not least, this site becomes important because it is here, in a temporary ground floor suite of this office tower, that Detroit's Department of Motor Vehicles lives in today, as one of the many government functions of the New Center.


General Motors Building retrofit Typical office floor reflected ceiling plan (existing)




General Motors Building retrofit Typical office floor plan (existing)






Spatial Ceiling diagram
